1 On August 17, 2015, Plaintiff and Petitioner Waste Management of Alameda County, Inc.
2 ("Waste Management") filed a Verified First Amended Petition for Writ of Mandate or Extraordinary
3 Relief and Complaint for Declaratory Relief ("Petition and Complaint") against Defendants and
4 Respondents City and County of San Francisco, San Francisco Board of Supervisors, San Francisco
5 Department of the Environment, and Deborah O. Raphael, in her official capacity as Director of the
6 San Francisco Department of the Environment (collectively "the City"). Waste Management named
7 Recology Inc. and Recology San Francisco (collectively "Recology") as Real Parties in Interest.

8 On December 9, 2015, the Court entered an Order Sustaining Without Leave To Amend
9 Demurrers To Waste Management's First Amended Petition For Writ Of Mandate (First Three Causes
10 Of Action). On April 29, 2016, the Court entered an Order Granting Defendants and Real Parties in
11 Interest's Joint Motion for Judgment on the Pleadings. Those Orders, which are incorporated in full
12 herein and attached hereto as Exhibits A and B, leave no cause of action for adjudication.

13 Accordingly, this Court ORDERS, ADJUDGES, AND DECREES as follows:

14 1. Plaintiff and Petitioner Waste Management of Alameda County, Inc. takes nothing by
15 its Petition and Complaint.

16 2. Judgment shall be entered in favor of Defendants and Respondents City and County of
17 San Francisco, San Francisco Board of Supervisors, San Francisco Department of the Environment,
18 and Deborah O. Raphael, and Real Parties in Interest Recology Inc. and Recology San Francisco.

19 3. Pursuant to a stipulation of the parties, Defendants and Respondents City and County of
20 San Francisco, San Francisco Board of Supervisors, San Francisco Department of the Environment,
21 and Deborah O. Raphael, and Real Parties in Interest Recology Inc. and Recology San Francisco, as
22 the prevailing parties, have waived recovery of fees and costs. The parties shall therefore bear their
23 own fees and costs.


