We designed this park with open flexible space, allowing use and personal interpretation by any age group, with the exception of the children's play area which is a dedicated space for young kids. In general, this is a good approach for park design, as parks need to accommodate a variety of user groups which change over time.
Program	Can there be chess board/checkers patterns in tables to provide that as an option?	The design provides flexible tables and chairs that could support game playing. The design team will research incorporating fixed tables with game tops to see if these can be incorporated into the design.
Program	I would like to know if there is an option for skateboarders. As lovely as all of the plans look, I anticipate skateboarders will use the paths inside the park areas. Also, is using the Under Ramp Park an option for skateboarding?	Skateboarding would not be appropriate here, but there are dedicated skateparks in other locations in the city, including Rec Park-owned Waller St. Skate Park in Golden Gate Park, SoMa West Skate Park and skate parks in Balboa Park, Crocker Amazon and Potrero del Sol. The low seatwalls are intended to be built with stone – a natural deterrent to skateboarders. Under Ramp Park will not feature a skateboard element given that such programming needs are met at the various aforementioned park spaces around the City.
Program	Basketball hoops in the planning?	Basketball courts are not included in the program design at this park. But the adjacent future Under Ramp Park design will provide sport courts, including basketball courts, at the corner of Folsom and Essex Streets.

The park is planned to be owned and maintained by the San Francisco Recreation and Park Department, which will manage this park as it does others throughout the City. Sleeping in parks is forbidden under Park Code between the hours of 8pm and 8am and Rec Park Rangers

Block 2 does not have a design yet, but current zoning allows a maximum height of 165' or 16 stories on the southeastern corner of the site; a maximum height of 85' or 8 stories on the western side of the site; and a maximum height of 50' or 5 stories for the townhomes fronting Clementina Street. Block 4 proposes a maximum tower height of roughly 500' and totaling 47 stories; a midrise building of 165' or 16 stories; and a townhome component of 70' or 6 stories.
Policy	Will there be "hours of operations" for the playground area?	Parks under the jurisdiction of the San Francisco Recreation and Park Commission all have the same opening hours of 5am to midnight, as defined in the City's Park Code. Changes to park opening hours are possible, with the approval of the Recreation and Park Commission. Communities who wish to modify park hours can work with Rec Park staff to put forward an alternative before the Commission.
Policy	Does the City or East Cut CBD have demographic data on families in the vicinity and the age of children who live nearby? Shouldn't the age of most children, which I'm guessing is mostly 0-5, drive the play area offerings?	The city does have demographic data on all neighborhoods including this one, and the CBD also tracks demographic data. However, this is a rapidly evolving area with changing demographics. Once data from the 2020 census is released, we will have better estimates.
